
PERCENTAGE OF DOLLARS SAVED OVER ORDINARY GLASS







Lawson Industries, Inc. warrants to the original owner, that any Lawson aluminum window or door shall be free of defects in material and/or workmanship, for the period specified below. This warranty is limited to products, which receive normal use and service and are subject to the conditions and limitations, as set forth below and begins on the delivery date.

LAWSON'S LIABILITY UNDER THIS WARRANTY SHALL BE LIMITED TO THE REPAIR OR, AT LAWSON'S OPTION, REPLACEMENT OF NONCONFORMING GOODS OR PARTS. LAWSON SHALL NOT BE RESPONSIBLE FOR ANY LABOR OR DELIVERY COSTS INCURRED IN REPAIRING OR REPLACING THE PRODUCTS, OR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES THAT MAY ARISE OUT OF A CLAIM FOR BREACH OF THIS WARRANTY. ANY REPAIR DONE UNDER THE WARRANTY PERIOD WILL NOT EXTEND THE ORIGINAL WARRANTY PERIOD.

LAWSON'S SOLE RESPONSIBILITY UNDER THIS WARRANTY IS LIMITED TO PROVIDING COMPONENTS OR PARTS NECESSARY TO REPAIR, AT LAWSONS OPTION, REPLACE THE PRODUCTS COVERED UNDER THIS WARRANTY. ANY PART OR PARTS OF THE WINDOWS OR DOORS THAT COMPLY WITH THE TERMS OF WARRANY, THE ORIGINAL WARRANTY PERIOD SHALL NOT BE EXTENDED BY SUCH REPAIR OR REPLACEMENT.

Heat Strengthened and Tempered Glass

The glass is warranted for a period of one (1) year from the date of purchase that heat strengthened glass and tempered glass meet at the time of sale ASTM Standard Specification C1048-92. Lawson Industries also warrants tempered glass purchased by the consumer at the time of sale the requirements of the Safety Glazing Certification Council ("SGCC").

The original flatness of glass is slightly modified by the heat strengthening process, causing reflected images to be more distorted than annealed glass. Warp, bow, and roller distortion are inherent characteristics of heat strengthened glass. Distortion of reflected images can not be entirely eliminated with even the best equipment and craftsmanship during the production of heat strengthened glass.

Laminated Glass Unit

Laminated glass is warranted to be free of defects resulting in visual obstruction or delamination for a period of ten (10) years from the date of purchase.

Insulated Glass Unit

Lawson Industries, Inc. extends a limited warranty for a period of ten (10) years from the date of purchase for seal failure causing impaired vision due to moisture, film or dust between the glass.

Glass Stress Cracks

Lawson warrants against stress cracks in glass panels, for a period of one (1) year from the date of purchase. This spontaneous glass breakage is when the glass develops a crack without sign of impact or added stress to glass. In cases of bona fide stress cracks, Lawson will replace the glass at no charge. Installation costs are not covered. Lawson reserves the right to determine the authenticity of the claim for stress cracked glass.

NON-GLASS COMPONENTS

Aluminum Framing

The aluminum frame and sash members are warranted to be free of defects in materials and workmanship, for a period of three (3) years from the date of purchase. Products are warranted against peeling, flaking, chipping, blistering and corrosion. All material will meet ASTM 2603.

Hardware is warranted to be free of defects in materials and workmanship, for a period of three (3) years from the date of purchase. In corrosive environments such as product being used within one (1) mile from the coast a stainless steel package is required for warranty.

Screen and Moving Parts

These components shall be warranted for a period of three (3) years, against defects in material and/or workmanship, from the date of purchase by Lawson.

Screens are not designed to, and will not prevent falls.

Damage, defects, or other issues resulting from causes outside Lawson Industries control are excluded from coverage under the Limited Warranty. Some causes the Limited Warranty does not cover, without limitation:

Damage due to improper installation or modification causing product failure including:

- Adjustments or corrections due to improper installation. Altered or reinstalled
- Failures due to modifications to the glass (e.g., glass tinting, security systems, improper painting or staining, insulated coverings, etching, etc.)
- Units improperly mulled or assembled by others
- Failure due to the use of non-Lawson hardware (e.g., locksets, trim sets, hinges, closers, panic hardware)
- Failure to properly install Lawson hardware.

Damage caused by the following;

- Condensation is not a product defect, but the result of excess humidity. Condensation, frost, mold, mildew, or fungus on product surfaces is not covered by the Limited Warranty
- Damage due to improper installation, maintenance or use, including use of a noncommercial door as a main entrance/exit door for a building other than a single
- Installation that is not in conformance with Lawson's installation instruction and applicable building codes.
- Non-standard installation, such as non-vertical or sloped glazing, upside down, or out of square.

- Installation or use in applications exceeding design standards.
- Structural settlements, movement, or vibration.
- Use of brick wash, razor blades or other inappropriate cleaners or chemicals.
- Non factory applied finishes (paint, coatings, etc.), applied sealants or caulking. Finishes applied by your local dealer/contractor are not covered by this warranty.
- Salt spray, acid rain, chemical or airborne pollutants, and other corrosive elements.
- Extreme weather events. Extreme or unusual atmospheric conditions. Hurricanes, Earthquakes, Tornadoes, etc.
- Water intrusion caused by wind driven rain and floods
- Misuse, abuse, modification, alteration, accident, negligence.
- War, insurrection, civil unrest, terrorism
- Acts of God
- Products not manufactured by Lawson

Minor imperfection in the product:

- Minor imperfections in glass, aluminum, and components that do not affect the product's structural integrity or significantly obscure vision. All minor imperfections need to meet ASTM standards in order to be acceptable.
- Minor variations in glass color
- Minor imperfections up to 1/4" along the edges of the paint.
- Slight Variations in color, gloss, texture of painted surfaces.

Caulking is used on installations to seal the frames of windows and doors against water or air penetration. Caulking is not considered a part of the Lawson product and therefore, is not covered under this warranty. Caulking is normally considered a maintenance responsibility of

Certifications and Ratings

Many Lawson products are labeled with certifications and data that are based of a single sample of the product at the time of manufacture. Ratings are based on a combination of computer simulations and physical testing of product samples. Performance of individual products may vary and will change over time, depending on conditions of use.

No Statement of Useful Life

This Limited Warranty is not a statement of the useful life of any Lawson Products.

Product Changes

Lawson Industries reserves the right to discontinue or make changes to an existing product. If the original component or product is unavailable, Lawson shall have the right to substitute such part or component that is determined to be of equal quality.

Prompt Notice of Claim

In the event a problem arises the buyer or user should notify Lawson Industries immediately, and in no case more than ninety (90) days from when a defect is first discovered.
